This form is to be completed by a party to a parenting order under [Part VII](#) of the [Family Law Act 1975 \(Cth\)](#) to ascertain the status of a child on the Family Law Watch List. Failure to fully complete this form may delay the actioning of your request.

**You must provide a certified copy of a Government issued identification**, such as a Drivers Licence or Passport.

**You MUST provide a return email address.**

The AFP will only respond to this enquiry by email. Please allow up to 10 days to receive a response.

### Privacy
